

Terms and conditions

- 1. Happy Stamp issuance period is from 25 Jul 2025 to 23 October 2025.
- Customers need to affix the required number of Happy Stamps on the promotion leaflet to redeem or purchase an item from the "Doraemon SUMMER Magic Fun" redemption programme.
- 3. you Members need to redeem the Redemption QR code with designated Points in you App and present the QR code with the designated price or free to redeem the "Doraemon SUMMER Magic Fun" at any Wellcome Supermarket checkout.
- 4. All redemptions or purchases of the "Doraemon SUMMER Magic Fun" products must be completed on or before 6 November 2025. Once the redemption period has expired, all outstanding redemptions shall immediately become invalid, and shall not be re-issued nor extended under any circumstance. (No redemption or purchase of "Doraemon SUMMER Magic Fun" services are available at Lok Ma Chau stores and the store outside Shui Chuen O Plaza).
- 5. For the "Doraemon SUMMER Magic Fun" Happy Stamp programme, you can get one Happy Stamp for every \$60 spent, two Stamps for \$120 spent, and so on when you spend at Wellcome stores. The Happy Stamp(s) shall be given under single transaction and at a discounted price.
- 6. If the purchased products need to be refunded/exchanged during the redemption period (Redeemed items are not returnable or exchangeable), the customer must present the relevant transaction receipt and return all the Happy Stamps indicated on the transaction receipt.
- 7. Customer should present the original copy of "Customer Receipt" and "Reservation Receipt" at the cashier to collect "Doraemon SUMMER Magic Fun" products. Photocopy or expired shall forthwith become invalid. It shall not be re-issued and/or shall become invalid if it is lost, damaged or defaced. If the customer fails to collect the item within the collection period, the customer shall forfeit the right to claim the item without any compensation. Wellcome reserves the right to handle the uncollected items at its sole discretion without liability. The arrival date of stock may vary depending on the actual situation. In the event of any delay in the arrival of the stock, the collection period may be postponed. No compensation shall be provided for any such delay.
- 8. Hang Seng enJoy Card 8% discount offer, other coupons or offers are not applicable to the redemption / purchase of "Doraemon SUMMER Magic Fun" products.
