

條款及細則

「AlipayHK x 惠康消費 \$300 減 \$30 推廣活動」 (“本推廣”)

1. **推廣期：**推廣期由 2025 年 9 月 1 日至 2025 年 10 月 31 日 (包括首尾兩天) (「推廣期」)。
2. **參與方式：**推廣期內，AlipayHK 用戶每月可透過 AlipayHK 流動應用程式 (「AlipayHK 應用程式」) 在綫下指定門市掃描指定宣傳物料之二維碼，即可於 AlipayHK 應用程式內惠康品牌 Channel 活動頁面領取價值港幣 30 元的禮券(「禮券」)。
3. **參與範圍：**港幣 30 元的禮券適用於以下其中一家門店：
(i) 惠康、(ii) Market Place by Jasons、(iii) Market Place、(iv) 3hreesixty 及 (v) Oliver's The Delicatessen。
在符合第 5 條的使用條件下及所有合資格優惠抵扣後，用戶透過 AlipayHK 應用程式於以上參與門店單筆淨消費滿港幣 300 元或以上可即時使用 1 (一) 張禮券。
4. 每張禮券只限換領後三 (3) 天內適用，逾期失效並不獲補發。每位用戶於推廣期內每個月只可參與本推廣一 (1) 次，並可通過關注惠康品牌 Channel 獲得更多推廣資訊。
5. 成功兌換禮券後，AlipayHK 將自動存放禮券至用戶的 AlipayHK 應用程式賬戶內，於符合使用條件時自動扣減。用戶須將 AlipayHK 應用程式更新至最新版本，於「首頁」內的「獎賞」，即可查看獎賞詳情。禮券數量有限，先到先得，領完即止，並以 AlipayHK 的電腦紀錄為準。AlipayHK 於任何情況下均不會對用戶未能成功領取有關獎賞及/或遺失有關獎賞而負上任何責任。
6. 以下解釋如何使用禮券/獎賞：
 - (i) **基本獎賞：**基本獎賞包括迎新禮券、指定商戶積分禮券、平台通用禮券、政府消費券及限定付款方式禮券等。
 - (ii) **基本獎賞優先次序：**順序為平台通用禮券優先，政府消費券排第二，限定付款方式禮券排第三。如果用戶有多於一張同種類的基本獎賞，金額最大的一張基本獎賞優先。面額相同時，則最早到期者優先。到期日相同時，則最早領取的基本獎賞優先。

- (iii) **優先獎賞：**優先獎賞比基本獎賞優先使用。如用戶有多於一張優先獎賞，面額最大者優先。面額相同時，則最早到期者優先。禮券到期日相同時，則最早 領取的優先獎賞優先。
 - (iv) **獎賞一齊用：**於適當情況下，一張優先獎賞可與一張基本獎賞或最多 10 張可累積基本獎賞同時使用。如果用戶同時有基本獎賞及可累積基本獎賞，面額最大的一張基本獎賞及可累積基本獎賞（最多 10 張計）中金額較大者先被使用。如一張基本獎賞與可累積基本獎賞（最多 10 張計）的面額相同時，可累積基本獎賞（最多 10 張計）優先使用。
 - (v) 各種禮券的使用方式受其相關條款及細則約束。一切以實際付款頁面為準。
 - (vi) 本活動的 AlipayHK 禮券為基本獎賞。
7. 每一位用戶只可根據上述條款及細則參與本推廣，於推廣期內領取相關條款及細則所限的獎賞/禮券。為免疑慮，「每一位用戶」是指使用 AlipayHK 應用程式和錢包服務的、具有法律行為能力的一名自然人，而非一個 AlipayHK 帳號。為進一步避免爭議，在下述情形，有關帳號將被視為由同一位用戶所使用，合共只可參與本項推廣一次：
- (i) 在同一部手提電話或移動設備上有關連，比如有多個帳號登錄或激活；
 - (ii) 若同一個帳號/手機號碼在多部手提電話或移動設備上有關連，比如登錄或激活；
 - (iii) 若同一張銀行卡號/信用卡號被綁定於多個 AlipayHK 帳號時。
當以上情況發生時，為確認領獎的用戶資格及預防帳號、手機號碼、設備或銀行卡被盜用的風險，AlipayHK 保留暫停或永久停止向相關賬號發放優惠的權利及保留追究權利。
8. 如果相關交易經扣減所有適用獎賞及優惠後的淨消費金額少於港幣 1 元，就不能在該交易使用獎賞。只使用政府消費券付款的交易例外，相關交易經扣減後的淨消費金額可以為港幣 0 元。
9. 本推廣所獲贈的獎賞不可用於購買商戶現金券/禮券、兌換現金及不可轉讓。如需退貨或退款，禮券所對應的金額將不作為退款款項，而相關禮券將不獲補發。

11. 如本推廣活動受政府機關指令須要停止舉辦的，或者推廣活動遭受嚴重網絡攻擊或系統故障須要暫停舉辦的，則推廣活動可能無法順利進行，此種情況視為不可抗力。AlipayHK 無須為因不可抗力造成的損害、損失、糾紛承擔任何責任。
12. AlipayHK 對任何商戶提供之產品及服務質素及供應量恕不負責。
13. AlipayHK 保留在毋須事先通知的情況下更改、暫停或取消本推廣或修訂其條款及細則之酌情權，AlipayHK 恕不就任何更改、暫停或取消承擔任何責任，並對所有事宜及爭議保留最終決定權。
14. 本條款及細則受香港法律規管，並按其詮釋。用戶並同意接受香港法院的司法管轄權。如本條款及細則的中、英文版有所差異，一概以英文版為準。

Terms & Conditions for
“AlipayHK x Wellcome’s Spend \$300 enjoy \$30 Rewards”
(“Promotion”)

When is this Promotion?

1. **Promotion Period:** This Promotion starts from 1 September 2025 to 31 October 2025 (both dates inclusive) (the “**Promotion Period**”).

What is the Promotion?

2. **How to Participate:** During the Promotion Period, an AlipayHK user who scans the QR code in the designated materials placed in the designated physical stores for this Promotion can proceed to redeem one (1) HK\$30 AlipayHK coupon (“**Coupon**”) from Wellcome’s Brand Channel Promotion Page within AlipayHK mobile application (“AlipayHK App”) every month.
3. **Promotion Scope:** Subject to the conditions of use as set out in Clause 5 below, each HK\$30 AlipayHK Coupon can be used only once for a single net transaction of HK\$300 or above after redeeming all applicable rewards and in accordance with the clauses below at any of the following physical outlets :
(i) Wellcome, (ii) Market Place by Jasons, (iii) Market Place, (iv) 3hreesixty and (v) Oliver’s The Delicatessen in Hong Kong via AlipayHK.
4. Coupons are valid for three (3) days upon redemption. Expired Coupons are invalid and will not be re-issued. Each Eligible User can only participate only once (1) in this Promotion every calendar month during the Promotion Period. Eligible Users can also follow the Wellcome’s Brand Channel for more promotional information.
5. Upon successful redemption of coupon(s), AlipayHK will store the coupon(s) in the AlipayHK App account of the user automatically. Coupon(s) will be deducted automatically in applicable circumstances. Coupons are limited in quantity and on a first-come-first-served basis. AlipayHK’s records shall prevail under any circumstances. The AlipayHK App must be updated to the latest version. Users may go to the “Home” page and select “Reward” to read details of respective coupon(s). AlipayHK shall bear no liability if users cannot perform a successful redemption of the relevant reward(s) and/or the relevant reward(s) is lost due to any circumstances.

How to use coupons / rewards:

6. Here is an explanation on how to use coupons / rewards:

- (i) **Basic Reward:** This includes welcome rewards, designated merchant A. Point coupons, Platform General Coupons, Government Consumption Vouchers and Limited Payment Method coupons.
- (ii) **Priority of Basic Rewards:** Platform General Coupons shall have 1st priority in usage, Government Consumption Vouchers 2nd and Limited Payment Method Coupons 3rd. If the user has more than one of the same kind of Basic Reward, the Basic Reward with the highest value will be used first. In case the Basic Rewards are of the same value, the one with the earliest expiry date will be used. If the expiry dates of the Basic Rewards are the same, the Basic Reward with the earliest redemption date will be used first.
- (iii) **Priority Reward:** This shall have priority in usage over Basic Reward(s). If there is more than one Priority Reward in the user's AlipayHK account, the Priority Reward with the highest value will be used first. In case the Priority Rewards are of the same value, the one with the earliest expiry date will be used. If the expiry dates of the Priority Rewards are the same, the Priority Reward with the earliest redemption date will be used first.
- (iv) **Using rewards together:** One (1) Priority Reward may be used in conjunction with one (1) Basic Reward or up to ten (10) Accumulative Basic Reward(s) in applicable circumstances. If a user has both Basic Reward and Accumulative Basic Rewards, whichever Basic Reward or Accumulative Basic Reward(s) (based on aggregate value up to ten (10) coupons) that has the highest value will be used first. If the value is tied, the Accumulative Basic Reward(s) (up to ten (10) coupons) will be used.
- (v) The use of different types of coupons may also be subject to further terms and conditions. Terms stated on the actual payment page shall prevail.
- (vi) For the avoidance of doubt, the Coupon(s) issued under this Promotion are Basic Rewards.

Other important terms to note:

7. This Promotion is offered only once to an Eligible User(s). An “Eligible User” refers to a natural person with legal capacity who uses the AlipayHK App and Wallet service, and not merely an AlipayHK account. To prevent the risk of theft or misuse of an AlipayHK account, mobile phone number, mobile device or credit card number, take note that in the following circumstances (i) Connection on the same mobile phone or mobile device, such as the logging in or activation of multiple accounts; (ii) connection of an AlipayHK account or mobile number on multiple mobile phones or mobile devices, such as the logging in or activation on such devices; or (iii) the same credit card number being connected to multiple AlipayHK accounts), AlipayHK may take steps to verify an Eligible User’s identity and/or suspend or terminate any promotion or reward relating to such account(s). AlipayHK reserves its right to take further legal action against such infringing account(s) and their relevant user.
8. Coupon(s) cannot be used in a transaction if the net amount after deducting the amount of all applicable reward(s) and discounts shall be less than HK\$1. Government Consumption Vouchers used solely in a transaction are exempted from this rule. The net amount after deducting the amount of Government Consumption Vouchers used solely in a transaction can be HK\$0.
9. Coupon(s) awarded in this Promotion cannot be used to purchase cash vouchers or gift certificates, or exchanged for cash or other products and are non-transferable. For goods return or refund, the amount on the coupon(s) will not be returned and the relevant coupon will not be re-issued.
10. If there is any breach of these terms and conditions or illegal, fraudulent or abusive behaviour relating to this Promotion or the use of any coupons, AlipayHK will forfeit such user’s eligibility and entitlement of Coupons forthwith without notice. AlipayHK reserves the right to cancel such transaction and to take legal action against the relevant user.
11. In the event this Promotion is stopped by any government agency’s orders or must be suspended due to server network attack or system failure or any circumstances beyond AlipayHK’s control, such event shall be regarded as a force majeure event, and AlipayHK shall not be held liable for any damage, loss or dispute therein.
12. AlipayHK shall not be liable or construed as providing any guarantee as to the quality and availability of the products and/or service provided by any merchant related to this Promotion.

13. AlipayHK reserves the right to change, suspend or terminate the Promotion or its terms and conditions at its sole discretion without prior notice. AlipayHK shall not be liable for any such change, suspension or termination and reserves the right of final decision of all the matters and disputes.
14. These terms and conditions shall be governed by and construed in accordance with the laws of Hong Kong and each user submits to the exclusive jurisdiction of the courts of Hong Kong. Should there be any discrepancy or inconsistency between the English and the Chinese version of these terms and conditions, the English version shall always prevail.
